WE MAINTAINED THE REFERRAL NETWORK OF ALL CAROLINA PEDIATRIC ONCOLOGY TREATMENT CENTERS AND THOSE IN CONTIGUOUS STATES. FINANCIAL ASSISTANCE TOTALING \$1,288,124 WAS PROVIDED. THE ORGANIZATION ADDITIONALLY HAD \$406,872 OF ITS OTHER PROGRAM EXPENSES SPECIFICALLY FOR FAMILY NAVIGATION CASE MANAGEMENT AND SUPPORT SERVICES.

THE ORGANIZATION ENHANCED ITS TREATMENT TRAVEL SUPPORT FOR FAMILIES THIS YEAR, WHEREIN IT PROVIDES THEM IMMEDIATE REIMBURSEMENT FOR TREATMENT TRAVEL AT ITS \$.25 PER MILE RATE, THEN SUBMITS ON THEIR BEHALF TO THE MEDICAID TRANSPORT VENDOR FOR THE HIGHER MEDICAID RATE TO WHICH THEY ARE ENTITLED, AND UPON RECEIVING THOSE FUNDS, REMITS THEM IMMEDIATELY TO THE FAMILIES. THIS REDUCES THE POTENTIAL FOR ELIGIBILITY AND PROCESS TIME ISSUES.
